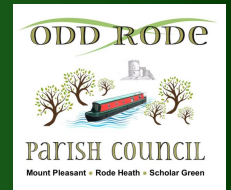

The government has announced plans to tackle what the head of the Environment Agency has called the "new narcotics" of fly-tipping and waste crime. The proposals would see checks on who is able to handle and dispose of waste, as well as a digital tracking system. Fly-tipping is the illegal dumping of rubbish, like mattresses and bags of waste, in parks, or on pavements. There were 1.13 million fly-tipping incidents in England in 2020-21, a rise of 16% on the previous 12 months. The cost, which includes clear-up and lost taxes, has been **estimated to be £1bn a year.**

Did you know?

- To count as fly-tipping, waste must be larger than a black bin's worth. If less, it's considered a littering offence
- If caught fly-tipping a person can receive a penalty fine or even go to prison
- On-the-spot fines start at £400 and have been known to increase to £50,000
- Households can also be fined indirectly if they pass their waste on to an unlicensed party who then dumps it
- On public land it is the responsibility of Cheshire East Council to clear it up and prosecute. Last year, nearly half a million investigations and prosecutions were carried out in the UK.

You are responsible for making sure that anyone you ask to dispose of waste on your behalf (for example a builder or contractor) is a registered waste carrier. Always ask to see their certificate. Always get a receipt confirming what they have taken and where they have disposed of it and details of any payment made.

Parish Precept ...

The Parish Council agreed a small increase in its share of the Council Tax for 2022/23.



The increase is 2% on the parish element of the Council Tax, i.e. an increase of 94p per annum on a band D (total parish charge the for year £48.28). Those on bands below D will pay less and those above more.

Highways Improvements ...

Following on from the Parish Council's success in getting CEC to reduce the speed limits on Congleton Road North and the A50, and extending the 30 mph limit in Thurlwood, the Council has got agreement from the CEC ward councillors and both Church Lawton and Astbury Parish Councils (the other two local councils in the CEC Odd Rode ward) to apply for funding for a refuge island on the A50 between Cherry Lane and Sandbach Road.

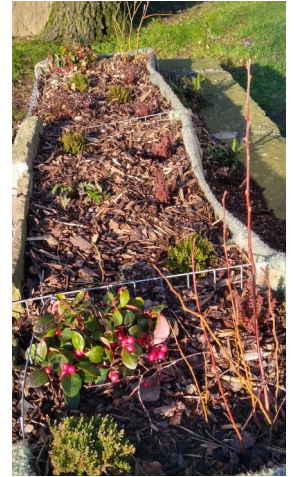
The need was established in 2018 when CEC Highways noted, in response to the Parish Council's request, "drivers overtaking vehicles that try to turn left into Sandbach Road plus pedestrians find difficult crossing the main road – Proposed: Refuge Island, this could eliminate the overtaking and act as a traffic calming near the junction plus will assist pedestrians crossing the road “.

The Parish Council has been pressing CEC ever since and took advantage of a new funding mechanism this year to push the project forward. If successful, it will probably be a couple of years before construction. Other highways needs are also being investigated by the Parish Council.

Environmental Enhancements ...

The Parish Council has created a wildlife friendly flower planter in Clare Street, Mount Pleasant.

Plants used are all acid loving hardies including heathers, ferns, blue - berries and other berry bearing shrubs that will provide food for wildlife once established.

The Council meets once a month, with other meetings as and when needed, and members do not receive remuneration. If you wish to apply, or want further information, contact the Clerk (details on back page).

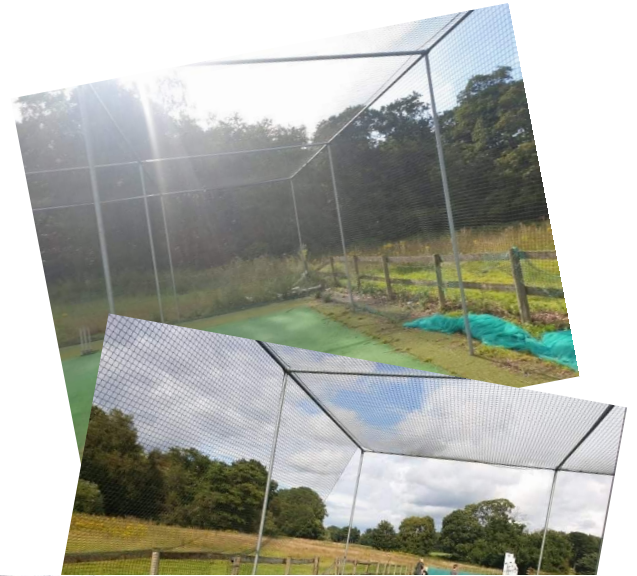
SUPPORTING OUR VOLUNTARY BODIES ...

Community Development & Engagement Grants

One of the ways that the Parish Council supports local voluntary and community groups by grant aiding them, Applications, which are considered in March each year, can be made for projects that are spread over more than one year (with a maximum grant of £1,500 per year).

Last year's grant's Scholar Green Village Hall (purchase of folding tables) £900.00; Rode Heath Village Hall (part refurbishment of ladies' toilets) £1,500.00; Rode Heath YPCC (repairs to roof) £1,000.00; Rode Heath Scout Group (new sound & lighting system) £1,500.00; Rode Park & Lawton Cricket Club (new nets) £1,500.00; Rode Heath Bowling Club (revenue expenditure – agreed as an exception to the usual policy due to the exceptional circumstances of the pandemic and in order to ensure the viability of the Club) £500.00.

Bird flu ...

The UK is facing its largest ever outbreak of bird flu with over 70 cases confirmed across the country since the start of November (6 being in Cheshire and 1 of these just to the west of Sandbach).

The UK Health Security Agency (UKHSA) has confirmed that the risk to public health is very low and the Food Standards Agency has said that bird flu poses a very low food safety risk for UK consumers and it does not affect the consumption of poultry or eggs.



Bird keepers should remain alert for any signs of disease, report suspected disease immediately and ensure they are maintaining good biosecurity on their premises.

The RSPCA was forced to put down 53 birds (42 geese and 11 swans) at the Winsford Marina following suspected cases of bird flu with the birds being 'very sick' and in an 'extremely poor condition'.

Residents are reminded to not touch or pick up any dead or visibly sick birds that they find. If they find dead wild swans, geese or ducks or other dead wild birds, such as gulls or birds of prey, they should report them to the Defra helpline.

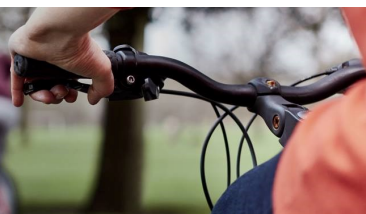

THE REVISED HIGHWAY CODE ...

The introduction section of The Highway Code has been updated to include 3 new rules about the new 'hierarchy of road users'.



The hierarchy places those road users most at risk in the event of a collision at the top of the hierarchy. It does not remove the need for everyone to behave responsibly. It's important that all road users:

- are aware of The Highway Code
- are considerate to other road users
- understand their responsibility for the safety of others

The updated code clarifies that:

- when people are crossing or waiting to cross at a junction, other traffic should give way
- if people have started crossing and traffic wants to turn into the road, the people crossing have priority and the traffic should give way
- people driving, riding a motorcycle or cycling must give way to people on a zebra crossing and people walking and cycling on a parallel crossing (a parallel crossing is similar to a zebra crossing, but includes a cycle route alongside the black and white stripes).



There is new guidance in the code about routes and spaces which are shared by people walking, cycling and riding horses.

People cycling, riding a horse or driving a horse-drawn vehicle should respect the safety of people walking in these spaces, but people walking

should also take care not to obstruct or endanger them.

People cycling are asked to:

- not pass people walking, riding a horse or driving a horse-drawn vehicle closely or at high speed, particularly from behind
- slow down when necessary and let people walking know they are there (for example, by ringing their bell)
- remember that people walking may be deaf, blind or partially sighted
- not pass a horse on the horse's left



There is updated guidance for people cycling about positioning themselves which includes:

- riding in the centre of their lane on quiet roads, in slower-moving traffic and at the approach to junctions or road narrowings
- keeping at least 0.5 metres (just over 1.5 feet) away from the kerb

edge (and further where it is safer) when riding on busy roads with vehicles moving faster than them

The updated code explains that people cycling in groups:

- should be considerate of the needs of other road users when riding in groups
 - can ride 2 abreast - and it can be safer to do so, particularly in larger groups or when accompanying children or less experienced riders
- People cycling are asked to be aware of people driving behind them and allow them to overtake (for example, by moving into single file or stopping) when it's safe to do so.

The updated code explains that people cycling should:

- take care when passing parked vehicles, leaving enough room (a door's width or 1 metre) to avoid being hit if a car door is opened
- watch out for people walking into their path



You may cross a double-white line if necessary (provided the road is clear) to overtake someone cycling or riding a horse if they are travelling at 10 mph or less .

There is updated guidance on safe passing distances and speeds for people driving or riding a motorcycle when overtaking vulnerable road users, including:

- leaving at least 1.5 metres (5 feet) when overtaking people cycling at speeds of up to 30mph, and giving them more space when overtaking at higher speeds
- passing people riding horses or driving horse-drawn vehicles at speeds under 10 mph and allowing at least 2 metres (6.5 feet) of space
- allowing at least 2 metres (6.5 feet) of space and keeping to a low speed when passing people walking in the road (for example, where there's no pavement). Wait behind them and do not overtake if it's unsafe or not possible to meet these clearances.



The updated code confirms that people cycling may pass slower-moving or stationary traffic on their right or left. They should proceed with caution as people driving may not be able to see them. This is particularly important:

- on the approach to junctions

- when deciding whether it is safe to pass lorries or other large vehicles

The code has been updated to clarify that when turning into or out of a side road, people cycling should give way to people walking who are crossing or waiting to cross.

There is new advice about new special cycle facilities at some junctions.

Some junctions now include small cycle traffic lights at eye-level height, which may allow cyclists to move separately from or before other traffic. People cycling are encouraged to use these facilities where they make their journey safer and easier.

There is also new guidance for people cycling at junctions with no separate facilities.



The code recommends that people cycling should proceed as if they were driving a vehicle where there are no separate cyclist facilities. This includes positioning themselves in the centre of their chosen lane, where they feel able to do this

safely. This is to:

- make them as visible as possible
- avoid being overtaken where this would be dangerous

The code now includes advice for people cycling using junctions where signs and markings tell them to turn right in 2 stages. These are:

stage 1 - when the traffic lights turn green, go straight ahead to the location marked by a cycle symbol and turn arrow on the road, and then stop and wait

stage 2 - when the traffic lights on the far side of the junction (now facing the people cycling) turn green, complete the manoeuvre

The code clarifies that when people cycling are going straight ahead at a junction, they have priority over traffic waiting to turn into or out of a side road, unless road signs or markings indicate otherwise.

People cycling are asked to watch out for people driving intending to turn across their path, as people driving ahead may not be able to see them.



The code has been updated to clarify that people driving or riding a motorcycle should give priority to people cycling on roundabouts. The new guidance says people driving and or

riding a motorcycle should:

- not attempt to overtake people cycling within that person's lane
- allow people cycling to move across their path as they travel around the roundabout

The code already explained that people cycling, riding a horse and driving a horse-drawn vehicle may stay in the left-hand lane of a roundabout when they intend to continue across or around the roundabout.

Guidance has been added to explain that people driving should take extra care when entering a roundabout to make sure they do not cut across people cycling, riding a horse or driving a horse-drawn vehicle who are continuing around the roundabout in the left-hand lane.



The code recommends a new technique when leaving vehicles. It's sometimes called the 'Dutch Reach'.

Where people driving or passengers in a vehicle are able to do so, they should open the door using their hand on the opposite side to the door they are opening. For example, using their left hand to open a door on their right-hand side.

This will make them turn their head to look over their shoulder behind them. They're then less likely to cause injury to:

- people cycling or riding a motorcycle passing on the road
- people on the pavement



For the first time, the code includes guidance about using electric vehicle charging points.

When using one, people should:

- park close to the charge point and avoid creating a trip hazard for people walking from trailing cables
- display a warning sign if you can
- return charging cables and connectors neatly to minimise the danger to other people and avoid creating an obstacle for other road users

In total, 10 sections of The Highway Code have been updated, with 50 rules being added or updated.

By registering with Cheshire Police Alert, you receive news and appeals, local crime information and crime prevention advice - direct to you as an e-mail, mobile text or voice message. Registering with the site is completely free, and not only allows you to receive messages about your local area, but also allows you to feed back information to your local policing teams to help them better police your neighbourhood.

Sheds and outbuildings ...

Many people don't secure their shed or garage in the same way they do their homes - often using an easy-to-break lock or padlock to protect valuable contents such as a car, bike or lawnmower. An opportunistic burglar will try a shed or garage first because they can find the tools they need to break into the main house.

First off, check that your insurance covers the contents of your shed or outbuildings from theft.

Think like a thief

Take a look at your shed and consider how you would break in. It's worth having a good padlock on the door with no exposed screws. Pay attention to hinges, as these are sometimes easily removable. If you have windows then these could be vulnerable unless they're secured with wire mesh or grills. And keep it locked at all times.

Alarm it

Consider a battery-operated shed alarm. They look low key but they respond to movement or door contact with an extremely loud siren.

Lock it, hide it or mark it

Don't give them the opportunity or the tools to commit a crime. Lock everything away securely. Tools can be locked inside a locker or box or secured with a chain. Secure your bike to the ground or a lockable stand within a locked shed or garage. Visit *Sold Secure* to search for ground anchors and other locks designed to fix to floors and walls.

It's always worth draping an old sheet or blanket over the top of mowers or bikes to keep them covered from view.

Although it might sound like stating the obvious, never leave your garage or shed door unlocked if you're not around.

Property marking your items is advisable and some tools can be painted with your name or postcode. Forensic marking is also an option.

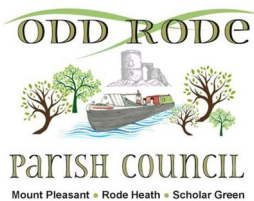

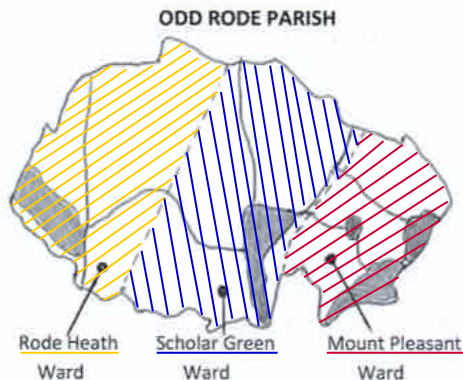
